6. All food items/meals will have to be served under buffet system without restrictions and quantity

**7. Price:**

All inclusive price to be quoted on per day basis **(Including all taxes like Service Tax, Luxury Tax, if any, etc.** and charges like rent for hall and furniture etc.

**8. Validity:**

Bids must remain valid up to 17.30 hours IST (Indian Standard Time) on 28.05.2016 for acceptance of ESIC.

**Submission and Opening of Bids:**

The offer complete in all respects along with Brochure of Hotel/ Resort/Accommodation must be submitted as per the prescribed format given in the 'Annexure' in sealed envelope marked "**BIDS FOR PROVIDING FOODS AT NASIK FOR ZONAL SPORTS PURPOSE**" addressed to the "**Regional Director, ESI Corporation, 108, Panchdeep Bhavan, N.M. The offers shall be opened at **16.00 hours on the same day i.e. 16.05.2016** at the above address. Bidders or their authorized representatives may remain present at the time of opening of tenders, if they wish to do so.

**EARNEST MONEY DEPOSIT (EMD):**

1. Bidder shall have to submit EMD of **Rs. 50,000/-** (Rupees Fifty Thousands only) by Account Payee **Demand Draft** of any **Nationalized Bank** drawn in favor of "**SBI ESI Fund A/c No.1**"
2. Bid received **without earnest money or in the form of other modes** will not be entertained / considered at all and rejected summarily.
3. **No interest** would be paid on the Earnest Money Deposit.

### **FORFEITURE OF EMD:**

1. The earnest money deposited (EMD) will be forfeited if the bidder withdraws or amends impairs and derogates from the tender in any respect within the period of validity of tender.
2. In case the successful bidder declines the work order, for whatsoever reason(s).

### **REFUND OF EMD :**

1. EMD will be refunded to the **unsuccessful** bidder within **thirty days** from the date of issue of work order to the successful bidder and no interest would be paid thereon.
2. EMD will be refunded to the **successful** bidder within **thirty days** after issue of letter of intimation or converted as Performance Security Deposit and no interest would be paid thereon.

### **PAYMENT TERMS:**

1. In any circumstance, no advance payment will be made.
2. **100%** payment will be made against invoice after successful execution of work order as per satisfaction and acceptance of this office.
3. Payment will be made to concerned party through **ECS** only.

### **TDS CLAUSE:**

At the time of payment TDS and any other Govt. levies applicable on bill as per Govt. of India instructions issued time to time shall be deducted.

### **AWARDING OF WORK ORDER :**

1. The tender will be evaluated on overall basis and Work order will be issued to the lowest evaluated bidder whose **consolidated total** is found to be lowest.
2. However, The Corporation **reserves the right** not to accept the lowest bid or to accept any bid or to divide the whole or a part of the work order among a number of bidders without assigning any reasons thereof & no correspondence will be entertained in this regard and decision of ESIC in this regard will be final and binding.

### **OTHER CONDITIONS:**

1. Before submission of the bid, bidders are required to make themselves fully conversant with the scope of the work, technical requirements and specifications etc., so that no ambiguity arises later on.
2. Bid is non transferable. Subletting the work or any part to any other agency is not allowed / permissible. **Conditional bid** of any type will not be accepted and rejected summarily.
3. All entries in the bid should be legible and filed clearly. Any overwriting or cutting which is unavoidable shall be signed by the authorized signatory. Use of correction fluid anywhere in tender is prohibited. In case use of correction fluid is noticed any where in tender then such tender shall be liable for rejection. All amounts shall be indicated both in words as well as in figures where there is difference between words and figures the amount quoted in words shall prevail.
4. In case of dispute, decision of the Regional Director, ESIC RO Mumbai will be deemed as final & binding.
5. Corporation reserves the right to reject any or all applications without assigning any reason
