2. They will be entitled to provisional pay at the rate equal to the last pay drawn in the lower post pending fixation of pay, if any, as per rules or at the minimum in the revised pay scale of PB-II (Rs. 9300-34800/-) with grade pay of Rs. 4600/- whichever is high.
3. The promotion of the officials will take effect from the date they assume charge of Social Security Officer/ BOM Gr. II/ Supdt.(Adhoc) at their ordered place of posting.
4. The promotion and posting of officials at Sr. No.4, 10 are ordered in public interest and they are entitled to TA, DA and Joining Time as per rules, wherever applicable.
5. The promotion on adhoc basis in the post will not confer any right on them to continue in post or for their regular promotion in future. The promotion of the above mentioned officials has been ordered on purely adhoc basis and they are liable to be reverted to their lower post at any time without notice or assigning any reason thereof.
6. After accepting the adhoc promotion any Assistant refuses/ declines regular promotion later on because of the place of posting not being convenient to him, it will be considered as misconduct and departmental action will be taken against him. Further, the adhoc promotions shall also be cancelled on his/her declining regular promotion and such officials shall not be considered for promotion for one year.

7. The officials are directed to inform their acceptance /joining/refusal by 06.01.2014. In absence any communication, it will be presumed that they have not accepted the promotion and no correspondence in future will be entertained in this matter. It may be noted that in case of non-acceptance of this promotion, the same would be offered to his / her junior (s) who may start drawing higher pay and other benefits for which the senior, who has refused promotion will not be entitled to any relief in future. Those who decline the offer of promotion will not be considered for promotion for a period of one year.
